The EUCC aligns with EU-specific regulations like GDPR and supports EU cybersecurity policies. It maintains the core principles of the CC, such as using Protection Profiles

(PPs) and Evaluation Assurance Levels (EALs), but incorporates additional requirements to address EU-specific security concerns. EUCC certificates will be given out from the beginning of 2025. However, we can already start the evaluation process for the certification.
